

## Limited Lifetime Warranty

This Limited Warranty applies to RYOBI hand tools defined as follows (“RYOBI PRODUCT”): Tape measures, Hammers, Shovels, etc.

### What is Covered?

The RYOBI PRODUCT will be free from defects in materials and workmanship for the usable life of the original product (the “Warranty Period”). If the RYOBI PRODUCT fails to conform to the Limited Warranty during the Warranty Period, One World Technologies, Inc. (“One World”), will, at its sole discretion, accept the return of the product and either repair or replace the RYOBI PRODUCT. If the RYOBI PRODUCT is no longer available, replacement may be made with a similar product of equal or greater value, at One World, sole discretion. This is your sole and exclusive remedy for breach of this warranty. This Limited Warranty will not apply to any repaired product. This Limited Warranty is not transferable from the original purchaser to subsequent owners, and the Warranty Period will not be extended in duration or expanded in coverage for any such transfer.

### What is Not Covered?

This Limited Warranty does not cover any of the following:

- 1) Damage to any RYOBI PRODUCT on which the serial number or other identifying markings have been removed or made illegible;
- 2) Damage caused by any modifications, alterations, tampering, or improper maintenance or repairs to the RYOBI PRODUCT;
- 3) Damage resulting from handling, storage, installation, or use of the Product which is improper;
- 4) Damage resulting from the addition of accessories not approved by One World;
- 5) Damage caused by abuse, misuse, poor maintenance, or failure to maintain the Product, as determined by One World, in its discretion;
- 6) Damage resulting from normal wear and tear and Acts of God; and
- 7) Freight damage.

### How to Obtain Service

If you believe the RYOBI Product may be defective, you may contact One World, at 1-800-525-2579.

One World, warranty obligations are conditioned on the owner:

- (a) notifying by calling the number above during the Warranty Period and providing a description of the alleged failure;
- (b) reviewing and completing the Warranty Claim Form;
- (c) shipping the product along with the completed Warranty Claim Form, at owners cost, **Freight prepaid and Insurance required**, to:

for repair or replacement. A copy of proof of purchase from an authorized retailer must also be included with

the shipment to confirm the product has not been transferred to another party from the original purchaser. Maintain the original receipt for future reference. (NOTE: PO BOXES are not valid return addresses due to carrier restrictions). Unless otherwise specified herein, One World, will bear all costs of return shipping to owner.

HOWEVER, One World, will have no warranty obligations with respect to a returned RYOBI PRODUCT, including but not limited to costs of return shipping to owner, if One World, determines, in its sole discretion after examination of the returned RYOBI PRODUCT, that this Limited Warranty does not apply to the RYOBI PRODUCT for any of the reasons set forth in the What is Not Covered Section above.
